ARTICLES OF INCORPORATION OF DIAKONIA COMPASSIONATE MINISTRY, INC. A NOT-FOR-PROFIT CORPORATION

In compliance with the requirements of Chapter 617, Florida Statutes, the undersigned persons do hereby make, subscribe, and acknowledge that they have voluntarily associated themselves together for the purpose of forming a corporation not for profit, the Articles which read as follows:

ARTICLE I NAME/PRINCIPAL CORPORATION OFFICE AND ADDRESS

The name of this corporation shall be: DIAKONIA COMPASSIONATE MINISTRY, INC. The corporation's principal office is located at: 425 Marlin Rd, North Palm Beach, FL 33408 and the mailing address is P.O. Box 14274, North Palm Beach, FL 33408

ARTICLE II PURPOSE

Diakonia Compassionate Ministry, Inc. is a charitable organization organized exclusively for religious, charitable, scientific and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exampt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. More specifically, Diakonia Compassionate Ministry, Inc. is organized to support and advance foreign and domestic missionary activity to proclaim the Good News of Jesus Christ to all nations, according to the command of our Lord Jesus Christ, and to engage in any other lawful purposes which are permitted within the State of Florida and the United States of America.

ARTICLE III REGISTERED AGENT AND OFFICE

The name and office address of this corporation's registered agent in Florida is Kathleen S. McCoy, 555 U.S. Highway One, North Palm Beach, FL 33408.

ARTICLE IV NON STOCK CORPORATION

The corporation shall be considered organized on a non-stock basis, and, therefore, certificates of shares of stock in the corporation shall not be issued.

ARTICLE V LIMITATIONS

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any Director or officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;

No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. The corporation shall not lend any of its assets to any officer or director of this corporation unless such loan program is regularly conducted as part of the activities of the organization and the qualification of the individual to participate in same is determined by a panel comprised solely of non-Board members], or guarantee to any person the payment of a loan by an officer or director of this corporation.

ARTICLE VI DIRECTORS/MEMBERS

Diakonia Compassionate Ministry, Inc. may (but need not) have voting members, and such membership, if any, and classes thereof, shall be as defined in the corporation's bylaws. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. No member or Director shall have any right, title, or interest in or to any property of the corporation.

ARTICLE VII BYLAWS

The Board of Directors named herein will adopt the first bylaws of this corporation.

Upon prompt notice, the bylaws may be amended, altered, or rescinded by a two thirds (2/3) affirmative vote of the members present at a meeting and entitled to vote.

ARTICLE VIII DEBT OBLIGATIONS AND PERSONAL LIABILITY

No member, officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or Directors be subject to the payment of the debts or obligations of this Corporation.

ARTICLE XII TERM OF EXISTENCE

The term of existence of this corporation is to be perpetual unless dissolved according to law.

ARTICLE X DISSOLUTION

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such

purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
