ARTICLE I Families And Society Together Enriching and Rebuilding, Inc.

ARTICLE II

ARTICLE III

This corporation is organized exclusively for charitable purposes, including, but not limited to, the relief of the poor, the distressed, or the underprivileged through the feeding of the homeless, providing meals to the elderly, providing clothes and household supplies to low-income families; lessening of the burdens of government, through the teaching of welfare to work classes, providing day care services, parenting classes, legal advice clinics; lessening of neighborhood tensions; and combating of community deterioration and juvenile delinquency through mentoring programs, tutoring classes, literacy classes, anti-violence and anti-pregnancy incentives, etc. Said corporation is also organized for the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered an to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

The Directors shall hold an organizational meeting at the call of the majority of the directors, to complete the organization of the corporation by electing or appointing officers and board members. The affairs and business of the corporation shall be managed by the Directors, consisting of not less than three, no more than fifteen members—who shall serve terms as prescribed in the by-laws.
