Article I – Name

The Name of the Corporation shall be:

NEW BETHEL AMEC, INCORPORATED

Article II – Principal Office

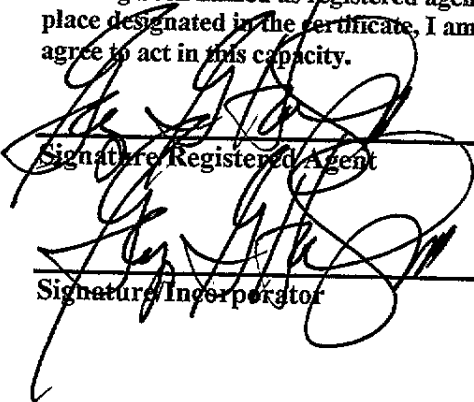

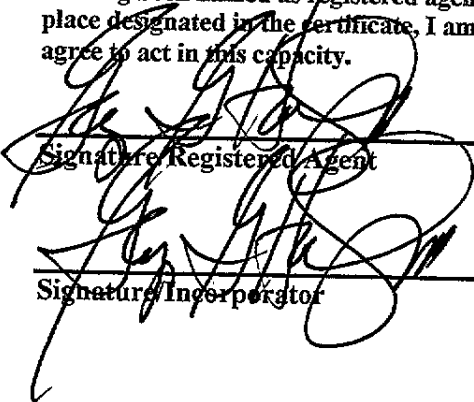
