Articles of Incorporation Of Operation Shoestring

(Dated: September 26, 2001)

Article I - Name

The name of the corporation shall be:

Operation Shoestring, Inc. and its principal office shall be in the City of Jacksonville, Duval County, Florida or at such other place as the Board of Directors, in accordance with the By-Laws of the corporation, may decide.

Article II – Principal Office

Article III - Purpose

The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on are to do any and all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, vis:

This is a nonstock, nonprofit corporation. The purpose of the corporation is to engage in any lawful act or activity for which nonprofit corporations may be organized under the General Corporation Law of Florida.

Said corporation is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), to wit;

1. Provide new shoes to economically disadvantaged school children in Northeast Florida.
2. To act with charitable concern for, and to help all needy children, regardless of race, religious affiliation, or national origin.
3. Receive, hold, and disburse contributions, gifts, grants, real and personal property, bequest, devises, and other funds for the above purposes.
4. Supply training materials and instruction for volunteers so that they may easily motivate others to contribute.
5. Assist in the formation of other organizations, groups or entities to establish similar programs.
6. Coordinate with and support the efforts of other individuals, groups, and organizations that have similar goals and purposes.

Article IV - Manner of Election

The method of election of the Board of Directors shall be provided for in the By-Laws of the corporation.

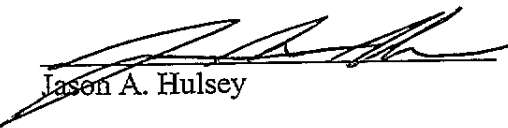

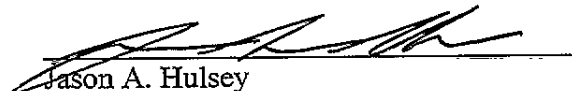

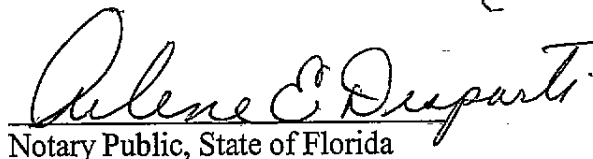
