ARTICLE I - NAME

The name of this corporation is HEAR THE CHILDREN, INC.

ARTICLE II - ADDRESS

ARTICLE III - PURPOSE

The specific purpose for which this corporation is organized is to provide telecommunications equipment, Internet service, engineering, and volunteer tutoring and mentoring to public schools in need of such resources. 
