# ARTICLES OF INCORPORATION Compliance with Chapter 617, F.S., (Not for Profit)>

# OMMUNITY ALL O

#### ARTICLE I - NAME

The name of the corporation is the ALL NATIONS YOUTH AND COMMUNITY DEVELOPMENT INC.

### ARTICLE II - PRINCIPAL PLACE OF BUSINESS & MAILING ADDRESS

The principal place of business and mailing address of this corporation is: 16951 NE 4th Avenue, Miami, Florida 33162.

#### ARTICLE III - PURPOSES

- A. The purpose for which this corporation is organized are exclusively religious, charitable, scientific, literary and education within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- B. Notwithstanding any other provisions of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law.
- C. Upon the dissolution of the organization, assets shall be distributed for one or more purposes within the meaning of Section501 (c) (3) of the Internal Revenue Code, or corresponding Section of any future Federal Tax Code or shall be distributed to Federal, State or local government for public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the Country in which the principal office of the organization is then located, exclusively for such purposes.
- D. Notwithstanding the specifics of A,B & C hereof, and not to be construed as giving this corporation more greater powers then those hereinabove listed, and for the sole reason to greater identify the philosophical intent of said corporation, the following are purposes of this corporation:
- 1. to facilitate, through on-going social, cultural, civic, and educational programs, the efforts of ALL NATIONS PRESBYTERIAN CHURCH to

create religious, educational, social and recreational activities for the youths of our community.

- to assist present and future religious and community leaders and others in their efforts to further the cause of concerns of youth and community development;
- to make every effort possible to foster a spirit of cooperation among the various organizations functioning in and for the benefit of the community:
  - to help identify and develop new resources for the community; 4.
- to help create an atmosphere of mutual understanding 5. between other ethnic groups of South Florida;
- to provide instrument for distribution of human services to all disadvantaged persons in the community and beyond.

# ARTICLE IV - MANNER OF ELECTION

The manner in which directors are elected or appointed is as stated in the bylaws. It shall generally follow the Presbyterian method of government.
