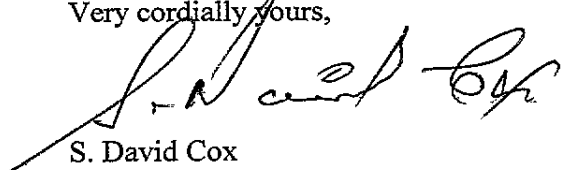

**ARTICLES OF INCORPORATION
OF
WE CAN DO ALL THINGS THROUGH CHRIST OUTREACH
MINISTRIES INC.**

PREAMBLE

For the most certain preservation and security of the principles of our faith. That at the end of this ministry, it may be governed in an orderly manner. Consistent with the accepted tenants of **GOD'S WORD**, the **HOLY BIBLE**, and more specifically, those of a **NEW TESTAMENT COVENANT**. For the purpose of preserving the liberties inherent in each, They are to reach out to the lost people of the world. In this ministry with respect to it's relation to other born again believers, we declare and establish these Articles of Incorporation.

1. NAME AND REGISTERED ADRESS

The name if this corporation shall be the **WE CAN DO ALL THINGS THROUGH CHRIST OUTREACH MINISTRIES, INC.** This corporation shall be located in Gainesville, Florida of Alachua County, at this registered address 722 SE 5th Avenue, Gainesville, Fl. 32601, or at such other places as the directors may be from time to time designate.

2. NATURE, PURPOSE AND OBJECTS

This corporation will be a corporation not-for-profit, and the general nature, purpose and objects of this corporation shall be exclusively religious and spiritual, as set forth below:

b. To attempt to, but no limited to, maintain a program of activity and affiliation with any other ministries, churches, associations, conventions, or denominations of our faith and belief.

c. To do any and all things usual and necessary, to further the aims and objects of the Lord Jesus Christ.

d. To serve a legal entity to handle the business affairs of the **WE CAN DO ALL THINGS THROUGH CHRIST OUTREACH MINISTRIES, INC.**, with the power to perform all acts not inconsistent with the aims and objects of said ministry.

e. To perform all functions and to have all powers as permitted by chapter 617, Florida Statutes 2001, and such powers as corporations not-for-profit may otherwise now or here after have no acquire; provided, however, that this corporation, in exercising any one or more of such powers shall limit itself to those powers as provided or described in Section 501(c) (3) of the International Revenue Code.

3. MEMBERSHIP

There will be no members of this ministry, except for the members of the Board of Directors and Officers.

4. TERM OF EXISTENCE

The term for which this corporations shall be perpetual unless otherwise directed by the Board of Directors. The term will begin on the date this corporation is approved by the Secretary of State, Tallahassee, Florida.

6.DIRECTORS AND RESIDENT AGENT

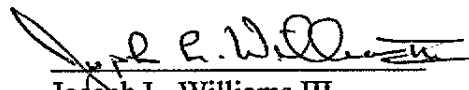

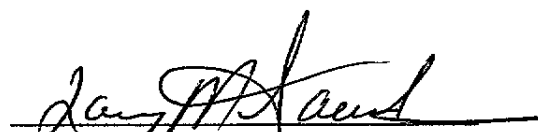

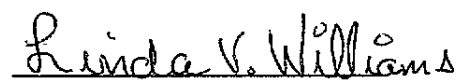
