**Articles of Incorporation
In Compliance with Chapter 617, F.S., (Not for Profit)**

Article I Name: South Florida F-Body Association, Inc.

Article II Principal Office:

Article III Purpose:

To assist association members with knowledge, understanding, and enjoyment of their F-bodies through the use of meetings, web site communications, and periodic events and gatherings with other members of the association. Dues paying members will have specific privileges relating to discounts on entry fees at events, access to the "Members Only" section of the web site, and the ability to purchase association products (t-shirts, car accessories, etc.) at cost.

To qualify as a member one needs to live in South Florida, Own any generation of F-body (Camaro or Firebird), and Timely pay the annual membership fee. Exceptions will be made for certain circumstances related to past members, who at one time or another, met all the qualifications to be a member of this association.

It is the intention of this association to protect this association's funds for the good of all members who choose to participate and utilize association functions and benefits. All funds will only be dispersed for association related activities and will require 3 signatures from current "directors" before they can be withdrawn from the association's accounts.

Article IV Manner of Election:

Each December 31st, or as close as conveniently possible, DIRECTORS ; 2 Representatives from each county, 1 Treasurer, and 1 Secretary will be elected from the pool of nominated candidates. The vote will be performed in person and only dues paying members will be allowed to cast votes. If necessary, some voting may be performed through the Web site (Sffba.com) in order to obtain and hear the voice of as many dues paying members as possible.

There are 3 counties, Dade, Broward, and Palm Beach, meaning that 9 individuals will be elected for a one year period. If for any reason a vote is needed more than once a year, then such nominations and elections will take place earlier. (i.e., if one of the elected officials moves from Florida, disability, etc.)

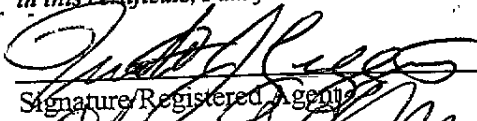

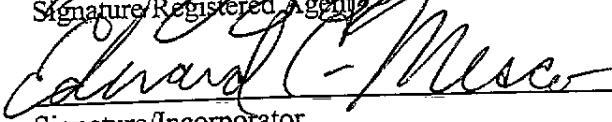
