**ONE:** The name and address of this principal corporation is New Hope Missionary Outreach Ministries, Inc. 2150 NW 130<sup>th</sup> Street, Miami, Florida 33167 in Miami-Dade County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.

**TWO:** This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, Religious and Charitable purposes. To Establish structured support service for Evangelistic, Prayer, Missionary Work and other Ministries to support the outreach ministries for the Body of Jesus Christ (The Church). In accordance with the Doctrine of the corporation creed/bylaws as a Pastor/Minister to spread the gospel of Jesus Christ. The religious programs will consist of but shall not be limited to: Food & Clothing Pantry, Group Homes & Shelter, HIV/AIDS, Counseling, Seminars, Workshops, Homeless, Soup Kitchen, and other programs to aid those who are in need.

**THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.


**SIX:** The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:

Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
