ARTICLES OF INCORPORATION OF CECILE M. SCOON HOUSE OF ART, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation not for profit under Chapter 617, Law of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

Article I - Name of Corporation.

The name of this corporation shall be CECILE M. SCOON HOUSE OF ART, INC...

Article II - General Nature of Business.

The purpose of this corporation is to provide opportunities for the entire community to learn about, display, and market art with a special interest in educating children and creative people who are not formally trained in the arts, and other lawful purposes.

Article III - Powers

The corporation shall have all of the statutory powers of a corporation not for profit.

Article IV - Members

The members of this corporation shall consist of the incorporators to these articles and such other persons as shall hereafter be determined by the members. The membership in the corporation shall continue until such time as the respective members


