**Articles of Incorporation
of
HALL'S LOVE & CONCERN MINISTRIES, INC.**

**ARTICLE I
NAME**

The name of this corporation shall be known, as **HALL'S LOVE & CONCERN MINISTRIES, INC.** herein after referred to as the Corporation.

**ARTICLE II
DURATION**

The duration of the Corporation is perpetual.

**ARTICLE III
PURPOSE**

The purpose of this Corporation shall be:

- A) To build and establish churches in the U.S. and abroad, to license and ordain ministries in the office for which they are called;
- B) To offer spiritual counseling for families, marriages, singles and adult couples.
- C) To perform any and all other services that are customary in ministry.
- D) To travel extensively conducting conferences, workshops, seminars and revival crusades activities in and around the world.
- E) To perform any and all other services that are customary in the ministry.
- F) To insure the financial stability of the Corporation, and in connection therewith to receive, acquire, hold, manage and administer funds for such purposes under which this corporation is organized;
- G) Notwithstanding any other provision of these Articles this corporation will not carry on any other activities not permitted to be carried on by a Corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code;
- H) Annual meeting of the Corporation shall be held in October of each year. Written Notices of

the meetings shall be sent to each member of the Board of Directors ten (10) days in advance of the meeting;

- D) Special meeting of the Corporation may be called by the Board at any time and shall be called by the Board on the written request of three (3) members of the Board of Directors of the Corporation. The purpose of the meeting except that for which the meeting has been called. Notice of time, place and purpose of each meeting of the Corporation shall be given at least two (2) days prior to such meeting unless a waiver of notice is obtained;

J) WAIVER OF NOTICE

Whenever any notice is required to be given to any Director, a waiver thereof in writing signed therein, shall be equivalent to the giving of such notice;

K) QUORUM

One-Third (1/3) of the total membership of the Board of Directors of the Corporation shall constitute a quorum;

L) VOTING PROCEDURES

Each member of the Board of Directors shall be entitled an opinion and all election shall be by appointment;

M) NUMBER

The Board of Directors shall consist of not less than three (3) nor more than twenty-five (25) members.
