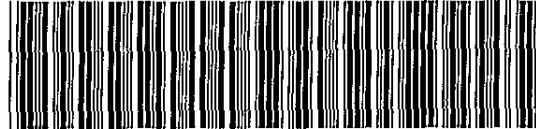

Any future United States Internal Revenue Law.



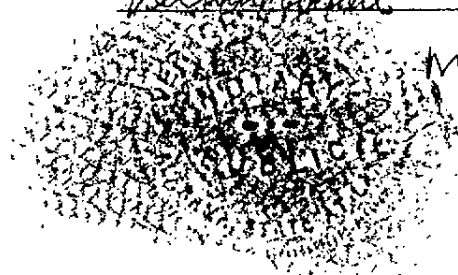
