ARTICLE OF INCORPORATION

We, the undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate ourselves together for the purpose of constituting a Church, to operate in accordance with the laws of God and in a non-profit corporate form pursuant to the applicable provisions of the Statutes of the States of Florida relative to corporation not for profit; and we hereby covenant and agree as follows:

ARTICLE I NAME AND ADDRESS

The name of this non-profit church corporation shall be Iglesia Cristiana Hefzi-bá Isaías 62 Inc.

The principal place of business and mailing address of this corporation shall be: 8450 Valencia Village Ln. 102 Orlando, Fl. 32825

ARTICLE II - PURPOSE

The general nature, object and purpose of this corporation is as follow:

- A- To establish and maintain a place for the worship of Almighty God, our Heavenly Father to provide for Christian fellowship for those of like precious faith, where the Holy God may be honored according to our distinctive testimony: to assume our share of responsibility and the privilege of propagating *the gospel of Jesus Christ* by all available means, both at home and abroad.
- B- Notwithstanding any other provision of these articles, the purposes for which Iglesia Cristiana Hefzi-bá Isaías 62 Inc. Is organized are exclusively religious, charitable, scientific literary, and educational within the meaning of section 501(c) (3) of The Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- C- Other objectives and purpose for which this Church is constituted and this corporation organized are:
 - 1- To disseminate the Gospel of Jesus Christ and The Word of God, to the end that the people of God may be conformed to the image of Jesus Christ.
 - 2- To bring both the families of believers and individuals believers, in the Lord Jesus Christ together in personal fellowship, both in the home and in cell groups.
 - 3- To regularly assemble together the members of this Church for fellowship one with another and to worship God in the spirit and in truth; and to cooperate in the assembling of the whole body of Christ.
 - 4- To provide basic New Testament discipleship to the members
 - 5- To involve every member of this Church in it's fellowship and activities and in the move of the Holy Spirit.

- 6- To solve family and marital problems so that the home life of each member is healthy and fruitful by Biblical standars.
- 7- To baptize in water, to anoint the sick with oil; to marry; to dedicate infants; to celebrate the Lord's Supper and to bury.
- 8- To act with charitable concern for and to help, not only all members of this Church can give regardless of race, social position or religious affiliation; to develop and carry out programs social action for poor, widowed, orphaned afflicted, imprisoned, underprivileged elderly persons, both within and without this Church.
- 9- To pray for the needs of all men and for local and national leaders and governments.
- 10- To support and encourage communication and extension of the Christian life and witness by sound and comprehensive preaching and teaching of the Holy Bible and Gospel of the Lord Jesus Christ and all men, both within this fellowship and elsewhere, not only by conventional modes, but also by all means which will accomplish such communication, extension, teaching and preaching, including but not limited to media of communication developed by modern technology; and in aid of such communication extension, preaching and teaching, but not for private profit, to sponsor, participated in, conduct or engage in radio broadcasting, television broadcasting, the printing or reproducing and publication of recordings, books, and other materials, the establishment and operation of a school or schools, and the holding and conducting or seminars, study groups, work shops and meetings, by either resident or traveling evangelists, teachers, or other elders; to receive offerings for such purposes; and to grant aid and pay reasonable compensation for services actually rendered to persons, firm, and corporations for such purposes.
- 11- To recognize, support and cooperate with the various ministries established by God and equip believers to fulfill their respective functions as members of the body of Christ and to bring the whole body of Christ to maturity and completion.
- 12- To ordain ministers; to assist in the establishment and maintenance of others Churches; and to send forth missionaries for the establishment and up building of the Churches, both domestic and foreign.

ARTICLE III PROPERTY

The Corporation shall have the power to buy, acquire, and hold title in fee simple, in trust, or otherwise, to both real and personal property, and improve, encumber, sell, convey and dispose of all such property, to borrow money, execute notes, bonds, and other evidences of indebtedness and to secure the same by mortgages and deeds or trust, annuity bond, and other instruments of indebtedness and to pay interest thereon, to improve, adapt, and use property held by it for: Iglesia Cristiana Hefzi-bá Isaiás 62 Inc. or the income there from in the religious, educational benevolent, or social activities of the: Iglesia Cristiana Hefzi-bá Isaiás 62 Inc. or its successor without financial profit to its

members except as may be necessary in the payment or salaries, or other compensation for services rendered, and the corporation shall have the power to erect and maintain buildings to be utilized by the said church, for the worship of God, for the training in Christian faith, and to build and maintain residences for the use and occupancy of the ministers of: Iglesia Cristiana Hefzi-bá Isaiás 62 Inc. in conformity with the by-laws of said corporation and all the power and rights granted to Corporations Not for Profit under the laws of the State of Florida.

ARTICLE IV MEMBERSHIP

The members of the corporation shall be all members in good standing at any given time of the: Iglesia Cristiana Hefzi-bá Isaiás 62 Inc. of: Orlando, Florida. Provided, however, neither the incorporators nor the members of the corporation shall have any vested rights, interest, or privilege of, in or to the assets, functions, affairs or franchises of this corporation, or any right, interest or privilege which may be inheritable, or shall continue after his membership ceases in the forenamed corporation. This corporation shall not have the power to buy, mortgage, sell encumber or deed or dispose of any property which it may acquire, without the consent or the direction of a two-thirds (2/3) majority vote of the members, or its successor.

ARTICLE V TERM

This corporation shall exist perpetually or until dissolved by due process of law. Should this corporation cease to exist as a legal entity and its charter be terminated, Title to all its property automatically shall become vested as follow: Upon the dissolution or the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue code of 1986, or corresponding section of any future federal tax code, or shall be distributed to The Federal, State or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the court of common pleas, of the county in which the principal office of the corporation is then located, exclusively for such purpose.

ARTICLE VI SUBSCRIBERS

ARTICLE VII OFFICERS

The officers who are to manage the affairs of this corporation shall be as follows: A President, a Vice-President, and a Treasurer, three officers shall be the Trustees (Directors) of the corporation, and such other officer that shall be said provided for in the bylaws, all of whom shall constitute and be and be the Official Board of Directors. They shall be elected for a period of time in accordance with the bylaws, and each shall hold office until his successor is elected and qualified, at it's regular annual meeting. The President shall sing and the Secretary shall attest all legal contracts authorized by the members of this corporation and the laws of the States of Florida.

ARTICLE VIII FIRST OFFICERS

The name of the officers-directors who are to manage the affairs of this corporation, and office which they will responsively hold until their successors are elected and qualified, and are as follow, to wit:

Each of these members is the Board of Directors.

ARTICLE IX BY LAWS

The bylaws of this corporation can be amended, altered or rescinded by a majority of the qualified members present and voting at any properly called business meeting, at which a quorum is present.

ARTICLE X AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. Every amendment must first be approved by the Official Board of Directors, (Trustees) then approved at a constituted meeting called for, two weeks in advance, and vote on by the members, and must be approved by a simple majority or those entitled to vote thereon.

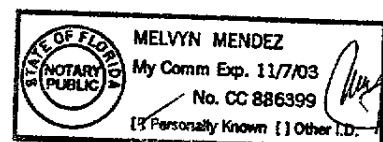
