ARTICLE I
NAME

The name of the corporation shall be IGLESIA HISPANA PENTECOSTAL MANASES, INC.
translated from Spanish to English as HISPANIC PENTECOSTAL CHURCH MANASES, INC.

ARTICLE II
PRINCIPAL ADDRESS

The principal place of worship for the organization shall be 877 Southwest 2nd Terrace, Deerfield
Beach, Florida 33441.

ARTICLE III
PURPOSE AND DURATION

IGLESIA HISPANA PENTECOSTAL MANASES, INC., is organized and operated with the
purpose of promulgating the Gospel of Jesus Christ, showing the love of Jesus Christ through multi
ministries to the Church of Jesus Christ and for the world.

This corporation is organized pursuant to the provisions of the State of Florida Non-Profit Laws.
The Corporation has a perpetual duration.

ARTICLE IV
NON-PROFIT

This corporation, being not for profit, shall have no shares of stock of any classification nor shall
any of the same be issued. No dividend shall be paid and no part of the net earning of the
Corporation shall be to the benefit of, or be distributable to its Directors, Officers, or other private
persons, except that the Corporation shall be authorized and empowered to pay reasonable
compensation for services rendered and to make payments and distribution in furtherance of the
purpose set forth in these Articles of Incorporation and its bylaws.

ARTICLE V
MANNER OF ELECTION

IGLESIA HISPANA PENTECOSTAL MANASES, INC. shall consist of a President, Vice-President, Secretary/Treasurer and three directors.

In the event of an absence or resignation of any officer, a new candidate will be recommended by the remaining executive officers. The new officer will be elected in a 2/3 majority vote.


