**ARTICLES OF INCORPORATION
OF
NEW HORIZON ADULT DAYCARE CENTER, INC.**

ARTICLE I:

The name of the corporation shall be **New Horizon Adult Daycare Center, Inc.**

This Corporation is organized pursuant to the FLORIDA Non - Profit Corporation Codes.

ARTICLE II:

The principal place of business and mailing address of this Corporation shall be **1622 West Blue Heron, Riviera Beach, Florida 33404, in Palm Beach County.**

ARTICLE III:

The specific purpose(s) for which the corporation is organized is as follows: This corporation is organized for transacting any and all lawful business for which corporations may be incorporated under the Florida Not for Profit Corporation Act and to distribute the whole or any part of the income there-from and the principal thereof exclusively for Adult Daycare purposes to aid the at risk, the poor, and the disadvantaged individual. Respite care, specialized social programs, nutritional management, and specialized activity. Activities provided for all clients on a daily basis. The corporation's programs will consist of Adult Daycare, but shall not be limited to, child care with emphasis on Special Needs Children; Family Preservation Program; Community Support Services; Seminars; Outreach Programs for Homeless and disadvantaged; Health Care Services; Teenage Pregnancy; Housing; Employment; Literacy; Counseling; Temporary Shelter; Job Training; Job Placement; and Acquisition; Substance Abuse Awareness and Prevention tutoring; AIDS Awareness; Computer Learning and other programs to aid those in need that will foster a life of self-sufficiency.

ARTICLE IV:

The manner in which the director are elected or appointed is as follows: The affairs of the Corporation shall be governed by a Board of Directors. (hereinafter referred to as the "Board") elected in accordance with the Bylaws, subject to the restriction that, except as specifically set forth to the contrary in the Bylaws, the exercise of any power or actions of the Board shall require the approval thereof by a majority vote of the Board present at a meeting at which a quorum of no less than two (2) Directors are present. The affirmative vote of any (2) Directors shall be necessary for all corporate action requiring a vote of the Board.
