In Compliance with Chapter 617, F.S., (Not for Profit), the undersigned, whom are citizens of the United States, desiring to form a Non-Profit Corporation, do hereby certify:

ARTICLE I NAME

The name of the corporation shall be:

LOVE CREATIONS HOUSE, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:
