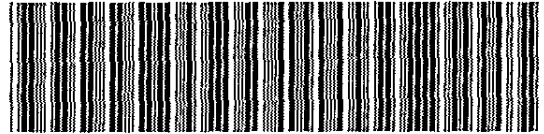


ARTICLE ELEVEN
