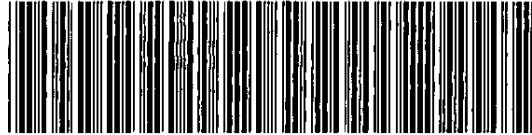

In compliance with Fla. Stat. Chapters 617 and 720, the following Restated Articles of Incorporation ("Articles") are hereby adopted for the purpose of organizing a not for profit corporation.

**Article 1
Name of Corporation**

The name of this corporation is Juniper Creek Homeowners' Association, Inc. (the "Corporation").

**Article 2
Principal Office**

The principal place of business and mailing address of the Corporation is: 4980 S. Ferdon Blvd., Crestview, FL 32536.

**Article 3
Purpose**

The purpose of the Corporation is to provide a homeowner association to operate a community located in Okaloosa County, Florida, and known as Juniper Creek Estates. The initial Declaration of Covenants, Conditions, Restrictions and Easements of Juniper Creek Estates ("Declaration"), was recorded in the official records of Okaloosa County, Florida, at Book 2320, Page 4715. Terms used in these Articles shall have the meaning stated in the Declaration or Bylaws.

**Article 4
Election of Directors**

The method of election of directors shall be as stated in the Bylaws of the Corporation.

**Article 5
Registered Agent**

The street address of the registered office of the Corporation is 4980 S. Ferdon Blvd., Crestview, FL 32536. The name of the registered agent of the Corporation at that address is Rick L. Goff.

Article 6
Indemnification

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

Article 7
Governing Documents; Amendment


Where the Declaration, Bylaws, or other governing documents of the community refer to the Articles of Incorporation, such reference shall be deemed to refer to the applicable provision in these Restated Articles of Incorporation, or in the absence of such provision, then to the applicable provision in the governing documents of the community, or in the absence of such provision, then to the applicable Florida law. If there is conflict among the governing documents of the community, then the decreasing order of priority is as follows: Declaration, Articles, Bylaws, and Rules.

During the Development Period, Declarant may unilaterally alter or revise these Articles. After the Development Period, these Articles may be amended by consent of 75% or more of the total Association voting rights, provided that no amendment is effective without the written consent of Declarant for so long as Declarant owns any Lot.

Article 8
Incorporator

The person signing these Restated Articles of Incorporation on behalf of the Corporation is: Rick L. Goff, President of the Corporation, whose address is 4980 S. Ferdon Blvd., Crestview, FL 32536.
