This Corporation shall have a perpetual existence.

ARTICLE 10. CAPITAL STOCK

Neither the members nor the members of the Board of Directors or officers of the Corporation shall be liable for the debts of the Corporation.

ARTICLE 14. EFFECTIVE DATE

These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 15. AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the members, and approved at a members meeting by a majority of the members unless all the Directors and all the members sign a written statement manifesting their intention that a certain amendment of these Article of Incorporation be made.

ARTICLE 16. DISSOLUTION

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposed within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or the state or local government for public purpose. Any such assets not to be disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principle office of the Corporation is located, exclusively for such purposes or to such organization or organizations, as said court shall determine, exclusively for such purposes.


