ARTICLES OF INCORPORATION

OF

A FLORIDA CORPORATION NOT FOR PROFIT In Compliance with Chapter 617, F.S.

ARTICLE I NAME

The name of the corporation is Synergy Empowerment Ministries, Inc.

ARTICLE II PRINCIPAL OFFICE

The principle place of business is $1818 - 29^{th}$ Avenue North, St. Petersburg, Florida 33713

ARTICLE III PURPOSE

The Corporation is organized for religious purposes, including without limitation, the following:

- (a) To provide a meaningful and organized structure and physical facility to accommodate public worship of the Lord Jesus Christ, enabling persons of all races, creeds and colors to worship together as a body of believers, committed to the Word of Jesus Christ;
- (b) To pledge itself in unselfish devotion and loyalty to the principles and doctrines of the Christian Faith;
- (c) To teach, preach, evangelize, facilitate and accommodate religious worship, and to promulgate the Gospel of Jesus Christ, through all available lawful means, whether through electronic and digital media (television or radio or internet), through written or verbal

communication, through missionary and evangelistic street outreaches to hopeless and despairing individuals of all races, creeds and colors, or through the development of educational programs at the preschool, elementary school, middle school, high school or graduate school levels.

(d) To encourage, promote and assist in the development and training of entrepreneurial skills to individuals seeking self-improvement techniques and empowerment opportunities.

ARTICLE IV MANNER OF ELECTION

The qualifications for members and the manner of their admission shall be as regulated by the Bylaws of the Corporation.

ARTICLE V NO DISTRIBUTION OF PROFITS

The Corporation is not organized for pecuniary profit. The Corporation shall not have any power to issue certificates of stock or declare dividends, and no part of its net earnings shall inure to the benefit of any member, director or individual. The balance, if any, of all monies received by the Corporation from its operations, after the payment in full of all debts and obligations of the Corporation, of whatever kind or nature, shall be issued and distributed exclusively for religious purposes.

ARTICLE VI PROHIBITION AGAINST POLITICAL ACTIVITIES

No substantial part of the activities of the Corporation shall be devoted to the promulgation of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in any political campaign on behalf of any candidate for political office.
