ARTICLE 1 - NAME

The name and address of this corporation is: CHARLES A. SCHEUERMAN CHARITABLE FOUNDATION, INC. 2691 East Oakland Park Boulevard, Suite 102, Ft. Lauderdale, Florida 33308.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

<u>ARTICLE III - PURPOSE</u>

This corporation is organized as a private charitable foundation for the purpose of transacting any or all lawful business, not for pecuniary profit, and not specifically prohibited to corporations under the laws of the State of Florida, including, without limitation, charitable, benevolent, eleemosynary, educational, historical, civic, patriotic, religious, cultural or scientific. This corporation:

- a. Shall distribute its income for each tax year at such time and in such manner so that it will not become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.
- b. Shall not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.
- c. Shall not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.
- d. Shall not make any investments in a manner that would subject it to tax under section 4944 of the Internal Revenue Code or corresponding provisions of any later federal tax laws.
- e. Shall not make any taxable expenditures as defined in section 4945(d) of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.
- f. Shall not engage, other than insubstantially, in activities that do not further an exempt purpose.

ARTICLE IV - MANNER OF ELECTION

The manner in which the directors are elected shall be stated in the bylaws of the corporation.

ARTICLE V - DISSOLUTION

Upon dissolution, the corporation's assets will be distributed for one or more exempt purposes or to the federal, state or local government for a public purpose.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT
