FLORIDA CITRUS MUTUAL TRADE ASSOCIATION, an association organized and existing under the laws of the State of Florida (the "Association"), in order to amend its Articles of Incorporation, in accordance with the requirements of Chapter 618, Florida Statutes, does hereby certify as follows:

1. The Articles of Incorporation of the Association were filed by the Secretary of State of the State of Florida on October 22, 2001, at which time the name of the Association was "FLORIDA CITRUS MUTUAL TRADE ASSOCIATION".

2. The Amendment to the existing Articles of Incorporation being effected hereby is that resulting from completely deleting Article I of the Articles of Incorporation as of the date hereof, and by substituting in its place the Article set forth below.

3. As amended below, Article I of the Articles of Incorporation has the sole effect of changing the Association's name from "FLORIDA CITRUS MUTUAL TRADE ASSOCIATION" to "FLORIDA CITRUS MUTUAL".

4. This amendment to the Articles of Incorporation was approved by resolution of the Board of Directors and Members of the Association, at duly called meetings thereof, on the 14th day of November, 2001.

5. The Amended Articles of Incorporation shall be effective immediately upon filing by the Secretary of State of the State of Florida, all required taxes and fees having been paid, and thereafter the name of the Association shall be "Florida Citrus Mutual", and Article I of the Articles of Incorporation of the Association shall read as follows:

The name of this association shall be Florida Citrus Mutual.




