We, the undersigned, desiring to organize a corporation not for profit under the laws of the State of Florida, Chapter 617, F.S., hereby associate ourselves to make, subscribe, acknowledge and file with the Department of State of the State of Florida, the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of this corporation shall be Orlando Xplosion Baseball Club, Inc.

**ARTICLE II
PRINCIPAL OFFICE**

The principal office shall be 4837 Tellson Place, Orlando, Florida, 32812.

**ARTICLE III
PURPOSE**

This Corporation is organized and shall be operated exclusively for the purposes of fostering national amateur sports competitions and/or to support and develop amateur athletes for such competitions.

**ARTICLE IV
MANNER OF ELECIION**

The Founder, Julio Navarro, shall appoint the Officers.

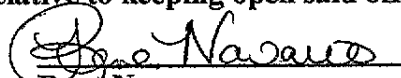

ARTICLE VIII
POWERS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE IX **DISSOLUTION**

Upon dissolution of the corporation assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, of the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
