The Articles of Incorporation of Multiplying Talents International, Inc.

Articles of Incorporation of the undersigned, whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Non-Profit Corporation Law of Chapter 617, Florida Statutes, do hereby certify:

Article One: The name of the Corporation shall be **Multiplying Talents International Inc.**

Article Two: The place in this state where the principal office of the Corporation is to be located is 7463-8 Beacon Hill Loop Orlando, FL 32818 in the City of Orlando, Orange County.

Article Three: The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. **Multiplying Talents International will be a faith-based leadership training organization designed to assist new nonprofit organizations with "how to" obtain their tax exempt status and to be a grant referral resource. Multiplying Talents, Inc. purpose is to assist individuals, organizations, and corporations with the completion of their forms to become tax exempt through the IRS. Secondly, Multiplying Talents International Inc., we conduct a annual conference for women called "Purity, Purpose, and The Promise Women's Conference.**

Article Four: The board of directors were appointed by the president.

Article Five: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
