ARTICLES OF INCORPORATION OF DESCENDANTS OF THE FIRST AMERICANS CULTURE & EDUCATION PRESERVATION ASSOCIATION, INC.

A FLORIDA CORPORATION NOT-FOR-PROFIT

ARTICLE ONE. NAME. The name of this corporation is: Descendants of the First Americans Culture & Education Preservation Association, Inc.

ARTICLE TWO. STATEMENT OF CORPORATE NATURE.

This is a not-for- profit corporation organized solely for general civic and educational purposes pursuant to the Florida Corporations Not For Profit Law set forth in Chapter 617 of the Florida Statutes.

ARTICLE THREE. DURATION.

This corporation shall have perpetual existence.

ARTICLE FOUR. GENERAL AND SPECIFIC PURPOSES.

The purposes for which this corporation is formed are as follows:

- (1) To lease, purchase, own, maintain meeting and office space for serving the needs of the total community.
- (2) To provide educational, informational programs serving the needs of both members and the community base.
- (3) To provide and promote Community Events for fund-raising and community service.
- (4) The purpose for which this corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 (c) 3 of the Internal Revenue code of 1986 or the corresponding provisions of any future United States Internal Revenue law, (as amended May 17, 1996).
- (5) To provide programs and projects related to the above purposes which may from time to time be instituted by the Board of Directors for said purposes governed by the by-laws and standard operating procedures duly implemented by this organization.
- (6) Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by any organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue code of 1986 or the corresponding provisions of any future United States Internal Revenue law.

"ARTICLE FIVE. MEMBERSHIP:

- (a) MEMBERSHIP: The qualifications for members and the manner of their admission are contained in the by-laws of this corporation.
- (b) RIGHTS AND LIABILITIES OF MEMBERS: The members of this corporation shall have no right, title, or interest whatsoever in its income, property, or assets, nor shall any portion of such income, property or assets be distributed to any member on the dissolution of this corporation. Members of this corporation shall not be personally liable for any debts, liabilities or obligations of this corporation, and shall not be subject to any assessments.

ARTICLE SIX. LOCATION OF PRINCIPAL OFFICE AND IDENTIFICATION OF REGISTERED AGENT:
