It is the desire of all members of the Board of Directors to dissolve this Florida Corporation for the purpose of refilling as a non-profit corporation.

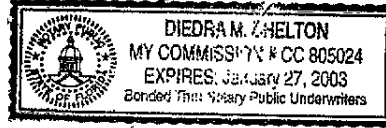

**ARTICLES OF INCORPORATION OF
Connie Bend Faith Based Training Institute, Inc.**

A NOT FOR PROFIT CORPORATION

I, the undersigned do hereby join together in the formation of a not for profit corporation pursuant to the laws of the State of Florida, following the terms and conditions, to wit:

**ARTICLE I
Name of Corporation**

The name of the corporation will be entitled:
'CONNIE BEND FAITH BASED TRAINING INSTITUTE, INC.',

**ARTICLE II
Principal Place of Business**

The corporation's principal place of business shall be located at 11680 Carapace Lane Jacksonville, Florida 32218. The Board of Directors may alter the principal place of business, to another Florida address.

**ARTICLE III
Purpose**

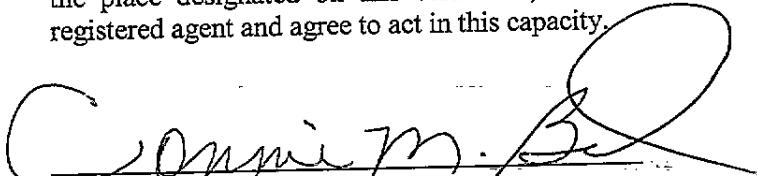

Registered Agent

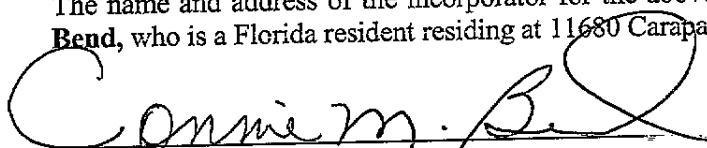

Indemnification

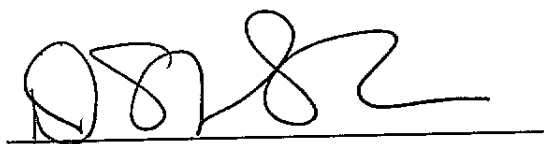
This corporation shall indemnify an officer or Board member, to the full extent permitted by law.
