A NOT FOR PROFIT CORPORATION

I, the undersigned do hereby join together in the formation of a not for profit corporation pursuant to the laws of the State of Florida, following the terms and conditions, to wit:

ARTICLE I Name of Corporation

The name of the corporation will be entitled: 'CONNIE BEND FAITH BASED TRAINING INSTITUTE, INC.',

ARTICLE II Principal Place of Business
