ARTICLES OF INCORPORATION

of

FULL GOSPEL DELIVERANCE TEMPLE CHURCH OF GOD AND CHRIST, INC.

ARTICLE I

The name of the Corporation is "Full Gospel Deliverance Temple Church of God And Christ, Inc." 3375 Avenue J, Apartment # 6  
Riviera Beach, Florida 33404

ARTICLE II

The Corporation is organized pursuant to the Florida Nonprofit Corporation Code.

ARTICLE III

The Corporation shall have perpetual duration.

ARTICLE IV

The Corporation will be organized exclusively for religious, charitable and educational purposes within the meaning of §501(c)(3) of the 1986 International Revenue code.

ARTICLE IV(a)

The purpose of the corporation is to give visible evidence of faith and fellowship to which God has called his people. To acknowledge ourselves to be a local manifestation of the Universal Church at which Jesus Christ ministered to the world by his Holy Spirit. To fulfill this calling through pastoring, and corporate worship services through a program of Christian by which our members may be built up in their faith and love, through proclamation of the Gospel by work and deed, and through ministering to human needs in the name of Christ.

Moreover, to provide support groups for marital counseling for pre-marriages and existing marriages; provide adult and youth outreach; revivals; counseling and assisting alcoholics and drug addicts; care groups to assist individuals socially and economically; and benevolence to assist those that are in financial distress.

ARTICLE V

The method of election of the Corporation's directors shall be set forth in the Bylaws of the Corporation.

ARTICLE VI

Notwithstanding any other provision of these articles the corporation will not carry on any other activities not permitted to be carried out by:

- (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law; or
- (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Internal Revenue law.


