ARTICLES OF INCORPORATION OF

WESTLAND UMBRELLA ASSOCIATION, INC.

In compliance with the requirements of Chapter 617, <u>Florida Statutes</u>, the undersigned hereby files these Articles of Incorporation for the purpose of forming a corporation not-forprofit and does hereby certify:

ARTICLE I

NAME

The name of the corporation is Westland Umbrella Association, Inc. ("Association").

ARTICLE II

PRINCIPAL OFFICE

The principal office of the Association is located at 9471 Baymeadows Road, Suite 402, Jacksonville, Florida 32256.

ARTICLE III

REGISTERED AGENT AND ADDRESS

James R. Young whose address is 9471 Baymeadows Road, Suite 402, Jacksonville, Florida 32256 is hereby appointed the initial registered agent of this Association.

ARTICLE IV

PURPOSE AND POWERS OF THE ASSOCIATION

This Association does not contemplate pecuniary gain or profit to the members thereof and the specific purposes for which it is formed are to provide for the operation, repair, maintenance and preservation of the Entries, Common Areas and Stormwater Management System within the development known as Westland Plantation and

any additions thereto as may hereafter be brought within the jurisdiction of this Association for this purpose to:

- (a) exercise all of the powers and privileges and perform all of the duties and obligations of the Association as set forth in these Articles as the same may be amended from time to time;
- (b) fix, levy, collect and enforce payment by any lawful means, all charges or assessments in connection with the Entries, Common Areas and Stormwater Management System; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied or imposed against the property of the Association;
- (c) operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District Permit No. (see EXHIBIT "A") and applicable District rules.
 - (d) operate and maintain the Common Areas.
- (e) levy and collect adequate assessments against Class B members of the Association for the costs of operation and maintenance of the Entries, Common Areas and Stormwater Management System;
- (f) acquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Association;
- (g) borrow money and, with the assent of fifty-one percent (51%) of the members, mortgage, pledge, deed in trust or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- (h) participate in mergers and consolidations with other non-profit corporations organized for the same purposes or annex additional residential property, provided that any such merger,

consolidation or annexation shall have the assent of fifty-one percent (51%) of the members; and

(i) have and to exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation Law of the State of Florida by law may now or hereafter have or exercise.

ARTICLE V

MEMBERSHIP

The members of the Association shall be Willow Lake Realty Investments, Ltd. ("Willow Lake"); Westland Communities Association, Inc., which shall govern the Lakes at Westland and the Villages at Westland; and Greens at Westland Communities Association, Inc. which shall govern the Greens at Westland (Westland Communities Association, Inc. and Greens at Westland Communities, Inc. shall hereafter be referred to as the "Sub-Associations").

ARTICLE VI

VOTING RIGHTS

The Association shall have two classes of voting membership:

Class A. The sole Class A member shall be Willow Lake and it shall be entitled to all the votes of the Association (one vote for each Sub-Association) until the earlier of (i) such time as it voluntarily relinquishes its rights as the sole Class A member or (ii) such time as Willow Lake shall own less than three (3) acres of the real property located in Duval County, Florida described on EXHIBIT "B" attached hereto.

Class B. The Class B member shall be the Sub-Associations until such time as the Class A member voluntarily relinquishes its rights as the sole Class A member. At that time, the Class B membership shall cease and be converted to Class A membership and the Sub-Associations shall be entitled to all the votes of the Association (one vote each).

ARTICLE VII

BOARD OF DIRECTORS

The affairs of this Association shall be managed by a Board of three (3) directors who need not be members of the Association. The number of directors may be changed by amendment of the Bylaws of the Association. The names and addresses of the persons who are to act in the capacity of directors until the selection of their successors are:

Willow Lake Realty Investments, Ltd. shall select any successor or replacement director as necessary until the Sub-Associations become the members of the Association. At the first annual meeting following such time as the Sub-Associations become the members of the Association, the members shall elect one (1) director for a term of one (1) year, one (1) director for a term of two (2) years and one (1) director for a term of three (3) years and at each annual meeting thereafter the members shall elect one (1) director for a term of three (3) years.

ARTICLE VIII

TRANSACTION IN WHICH DIRECTORS OR OFFICERS ARE INTERESTED

No contract or transaction between the Association and one or more of its directors or officers or between the Association and any other corporation, partnership, association or other organization in which one or more of its directors or officers are directors or officers or in which they have a financial interest shall be invalid, void or voidable solely for this reason or solely because the director or officer is present at or participates in the meeting of the Board or committee thereof which authorizes the contract or transaction or solely because his/her or their votes are counted for such purpose. All such contracts or transactions shall, however, be fair and reasonable and upon terms reasonably comparable to those which could be obtained in arms length transactions with unrelated entities. No director or officer of the Association shall incur liability by reason of the fact that he/she is or may be interest in any such contract or transaction.

Interested directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors or of a committee which authorized the contract or transaction.

ARTICLE IX

DISSOLUTION

The Association may be dissolved with the assent given in writing and signed by not less than fifty-one percent (51%) of the members. Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any non-profit corporation, association, trust or other organization to be devoted such similar purposes. In all events upon termination, dissolution or final liquidation of the Association. responsibility for the operation and maintenance of the Stormwater Management System must be transferred to and accepted by an entity which would comply with Section 40C-42.027, Florida Administrative Code, and be approved by the St. Johns River Water Management District prior to such termination, dissolution or liquidation.

ARTICLE X

DURATION

Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The Association shall exist in perpetuity.

ARTICLE XI

AMENDMENTS

Amendment of these Articles shall require the consent of fifty-one percent (51%) of the entire membership.

ARTICLE XII

DEFINITIONS

All defined terms contained in these Articles shall have the same meanings assigned to them by the Bylaws.
