The undersigned, for the purpose of forming a NOT FOR PROFIT Corporation under Chapter 617.0202, F.S. hereby adopts the following Articles of Incorporation:

**ARTICLE ONE: NAME:** The name of the corporation shall be **TWO VISIONS/DOS VISIONES, Inc.**

**ARTICLE TWO: PRINCIPAL PLACE OF BUSINESS:** The principal place of business for said corporation is: 2023 Lori Ann Street, Brandon, FL 33510.

**ARTICLE THREE: PURPOSE:** The purpose of the corporation is to transact any and all lawful business for which NOT FOR PROFIT Corporations may be incorporated under Chapter 617.0202, F.S. **TWO VISIONS/DOS VISIONES, Inc.** will develop awareness of the risks that exist for the Hispano/Latino Community by developing social events by way of conferences and a prevention and educational magazine. To encourage the Hispanic/Latino community as a whole to examine new philosophies and ideas that might improve their outlook in life and to become involved in the daily decisions that impact their lives on issues such as; health, housing, immigration, politics and economics, among others. It will facilitate the process of creating public policy when necessary. **Two Visions/Dos Visiones, Inc.**, may do writings of all types, including printing, publishing, distributing, etc.; and take advantage of any and all opportunities, ventures and spin-offs that are legally available.

**ARTICLE FOUR: APPOINTMENT OF DIRECTORS:** Directors will be elected or appointed based on the following criteria: knowledge on issues affecting the Hispanic/Latino community, significant experience dealing in areas such as Hispanic Marketing, Advertising and Electronic Media Production. The appointment/nomination of candidates must be evaluated and approved by incorporators to determine candidates' qualifications and/or experience prior to their appointment/nomination.

**ARTICLE FIVE: DIRECTORS:** The Board of Directors of the NOT FOR PROFIT Corporation shall consist of no less than three (3) and no more than four (4) members.

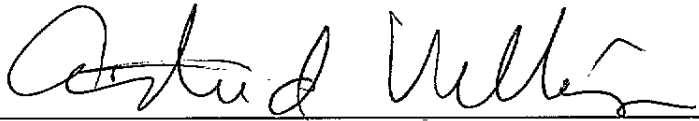

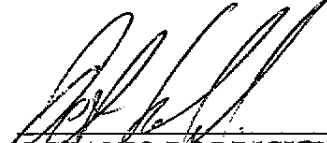
