## **ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE I                      NAME**

The name of the corporation shall be:  
Bay Area Junior Golf Tour, Inc.

### **ARTICLE II                      PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:  
2312 Sunview Avenue  
Valrico, FL 33594

### **ARTICLE III                      PURPOSE**

The purpose for which the corporation is organized is:  
To plan, organize and manage a junior golf organization dedicated to children ages 6 through 18 years old. The corporate Officers will negotiate the use of private and public golf course facilities for a discounted rate, which will be shared by the organization's members. The corporation will endeavor to raise the academic standards of the junior members by awarding points for academic achievement. The corporation will also establish a scholarship fund with excess earnings and sponsor donations that will be awarded to junior members to be determined by the Officers.

### **ARTICLE IV                      MANNER OF ELECTION**

The manner in which the directors are elected or appointed:  
The corporation will be established with the three principal Officers listed in Article V below. The term of office for each Officer shall be five years, commencing October 1, 2001. Officers will not have term limitations. Beginning on October 1, 2006 and every five years thereafter, the Officers will cast a written ballot to re-elect incumbent Officers or elect new Officers appointed by the incumbent Officers. Officers may resign their positions at any time upon written notification to the President of the corporation. Upon resignation of an Officer, a new Officer will be appointed by the remaining Officers. If an Officer is unable to serve due to illness or death, a new Officer may be appointed by the remaining Officers.
