Thank you again for your continued assistance and taking the time this morning to provide the above referenced association with direction on how to remedy the inadvertent error, which resulted in the inactivation of their corporation.

As directed, enclosed please find a fully executed UBR form along with an association check in the amount of \$61.25. For record purposes, below please find a recap of sequence of events that prompted this correspondence and the request for reinstatement:

- Original UBR Form and check was not received
- Effective October 1, 2002, Capital Realty Advisors, Inc. was awarded the Management Service contract and became the new Registered Agent for the Sandalwood Homeowners Association, Inc.
- I spoke with you during that week to inquire as to the status of receipt of the UBR Form and corresponding check. You stated that none had been received, directed us to print out UBR form from internet and send to your attention with \$61.25 check and postmark that day
- In an effort to meet this deadline, the President of the Association cut check from personal account, printed out UBR Form, had signed and mailed to Division of Corporations
- On this date, Management researched online the status of this account and it was denoted "inactive". You were contacted and this information was presented and you advised that there was no record of receipt for any checks or forms. You then directed me to print out another form, have fully executed, send another check for \$61.25 along with a brief memo outlining the sequence of events.

Again, you have been very helpful and understanding. On behalf of the Sandalwood Homeowners Association, Inc. Board of Directors, we thank you for promptly resolving this matter, reinstating the Association, and being so cooperative.
