# **ARTICLES OF INCORPORATION**

In Compliance With Chapter 617, F.A., (Not For Profit)

#### Article 1: Name

The name of the organization will be The Pride Foundation of Tampa Bay, Inc.

## **Article 2: Principal Place of Business & Mailing Address**

The address of The Pride Foundation of Tampa Bay, Inc. will be 201 West Laurel Street #512, Tampa FL, 33602.

#### **Article 3: Purpose**

The Pride Foundation of Tampa Bay, Inc., is organized exclusively for charitable purposes, more specifically to end discrimination and bias based on sexual orientation and gender identity through educational programs, cultural awareness and community development. To this end, The Pride Foundation of Tampa Bay, Inc., Inc., shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

#### **Article 4: Election Of Directors**

For the initial ten (10) months of operation, Directors of the organization shall be the founders of The Pride Foundation of Tampa Bay, Inc. The Directors may – within that ten (10) month period – may by a majority vote expanded the Board of Directors to obtain certain skills and areas of expertise required to develop The Pride Foundation of Tampa Bay, Inc.'s, charitable pursuits. Commencing in January of 2002 and the establishment of a membership, the Directors will be elected annually for a year term by a majority vote of the membership at the Annual Meeting to be conducted every December.
