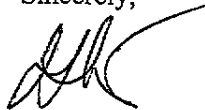

ARTICLES OF INCORPORATION
OF

MARTIN COUNTY SPECIAL NEEDS TRAINING, INC.
A FLORIDA CORPORATION NOT FOR PROFIT
(Florida Statute 617)

The undersigned, acting as incorporators for the purposes of forming a Not For Profit Corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such Corporation.

ARTICLE ONE

The Corporation shall be known as **Martin County Special Needs Training, Inc.**, having its principal address and mailing address of the corporation at **3605 SE Salerno Rd., Stuart, FL 34997.**

ARTICLE TWO

The purpose for which the corporation is established is to provide training and other services intended to promote independence and self sufficiency in individuals with special needs, and to promote and provide support for such services for special needs people.

ARTICLE THREE

The incorporators shall be the initial Directors of the corporation. Elections for successor directors shall be in accordance with the bylaws of the corporation. The incorporators and initial directors are:

- A. Elizabeth R. Feldman, 5181 Nassau Terrace, Stuart, FL 34997;
- B. Jerry Cohen, 13 Fairway Circle S, Manahassett, NY;
- C. Charles Feldman, 5181 Nassau Terrace, Stuart, FL 34997;

ARTICLE FOUR

This corporation may conduct any lawful business permitted under the laws of the State of Florida consistent with its not for profit status.

ARTICLE FIVE

The street address of the Registered Office of the corporation is **3605 SE Salerno Rd., Stuart, FL 34997**. The registered agent at that office is **Elizabeth R. Feldman**, whose residence address is **5181 Nassau Terrace, Stuart, FL 34997**. The acceptance of the Registered Agent is attached to this charter.

ARTICLE SIX

The Directors shall initially serve for a term of one year, which term shall thereafter be in accordance with the bylaws.

ARTICLE SEVEN

There shall initially be three classes of membership, which may be augmented or reduced as provided in the bylaws. The three initial membership classes shall be:

- A. General voting members as more particularly described in the bylaws;
- B. Adult trainee non-voting memberships for adult trainee program participants as more particularly described in the bylaws; and
- C. Minor trainee non-voting memberships for minor trainee program participants as more particularly described in the by-laws.

Membership shall not be transferrable.

Memberships shall be granted and may be terminated as set forth in the bylaws.

The initial general voting members shall be:

- A. **Elizabeth R. Feldman**, 5181 Nassau Terrace, Stuart, FL 34997;
- B. **Jerry Cohen**, 13 Fairway Circle S., Manahassett, NY;
- C. **Charles Feldman**, 5181 Nassau Terrace, Stuart, FL 34997;

ARTICLE EIGHT

Upon dissolution or liquidation of the corporation, any remaining assets shall be distributed to one or more organizations providing services to special needs individuals, which organizations may be chosen by the Board of Directors, or, if no such selection is made by the

Board, then the net assets shall be distributed to one or more organizations providing services to special needs children as determined by the Circuit Court in and for Martin County, Florida.

ARTICLE NINE

The life of the corporation shall be perpetual.

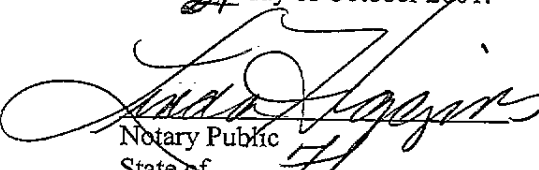

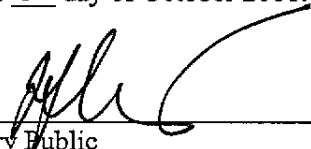
