Article 9. Provisions for dissolution of this corporation

Upon the dissolution of this corporation, its assets remaining after payment or provisions for payments, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or the state or local government, for a public charitable purpose.

Article 10. Provisions for operation of the corporation

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except otherwise as provided by Section 501 (h) of the IRS Code), and this corporation shall not participate in, or intervene in, (including the publishing of, or in opposition to, any candidate for public office).

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation SHALL be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its tax exempt purposes set forth in these articles.

Notwithstanding any other provisions of these Articles, this corporation shall NOT carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the IRS Code or (2) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

In any taxable year in which this corporation is a private foundation as described in Section 509(a) of the IRS Code, the corporation (1) shall distribute its income for said period at such time and manner as not to subject itself to tax under Section 4942 of the IRS Code, (2) shall not engage in any act of self-dealing as defined in Section 4941(d) of the IRS Code, (3) shall not retain any excess business holdings as defined in Section 4943(c) of the IRS Code, (4) shall not make any investments in such a manner as to be subject to tax under Section 4944 of the IRS Code, (5) shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.
