ARTICLES OF INCORPORATION
OF
CITIZENS FOR GOOD LEADERSHIP, INC.

ARTICLE I
NAME

The name of this Corporation is CITIZENS FOR GOOD LEADERSHIP, INC.

ARTICLE II
DURATION

This Corporation shall have perpetual existence.

ARTICLE III
PURPOSE

The Corporation shall be organized and operated exclusively under § 617.0301 of the Florida Not For Profit Corporation Act, as now in effect or as may hereafter be amended (the "Act").

In furtherance thereof, the Corporation may receive property by donation, gift, devise or bequest, invest or reinvest the same, and apply the income and principal thereof, as the Board of Directors may from time to time determine, either directly or through contributions to any political organization or organizations, candidate or for education on civic issues.

In furtherance of its corporate purposes, the Corporation shall have all the general powers enumerated in § 617.0302 of the Act, together with the power to solicit grants and contributions for such purposes.

ARTICLE IV
MANNER OF ELECTION

The initial Board of Directors shall be comprised of those Directors named in the Article V of these Articles of Incorporation. Thereafter, the Directors shall be elected at each annual meeting of the Members and each director shall hold office until the next annual meeting of Members and until the director's successor has been elected and qualified, or until the director's earlier resignation or removal from office.

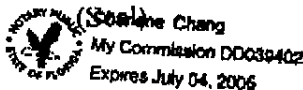

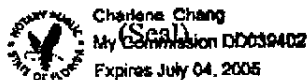
