ARTICLES OF INCORPORATION FOR SAWMILL RIDGE NEIGHBORHOOD ASSOCIATION, INC.

Pursuant to Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of this corporation shall be **SAWMILL RIDGE NEIGHBORHOOD ASSOCIATION, INC.**

ARTICLE II PRINCIPLE OFFICE

The principle place of business for **SAWMILL RIDGE NEIGHBORHOOD ASSOCIATION, INC.** will be 2120 Derringer Circle W., Jacksonville, Florida 32225

ARTICLE III PURPOSE

The purpose for which this corporation is organized is to preserve and improve the quality of the neighborhood and to protect and enhance property values and the integrity of our community.

To improve the protection of its members and their properties.

ARTICLE IV MANNER OF ELECTION

Each officer and member of the Board of Directors shall be a member of this association.

Officers of this association shall be President, Vice-President, Secretary, Treasurer, and Representative. The officers shall perform the usual duties of their offices, transact business in the interval between association meetings and report such business transacted to the membership at its regular meeting. Officers will perform such other duties as may be referred to them by the association.

The Board of Directors shall consist of the officers and three other active members that make up the Architectural Committee and shall be elected in the same manner and at the same time as the officers.

The BI-annual election of officers shall be held the first Week in November. After nominations are made, an appointed chairperson who is not a candidate for any office will distribute the ballots to voting members present. After the voting is closed, the chairperson will collect the ballots and announce the positions elected. All persons will take office at the close of the December meeting.

The nominating chairperson shall be elected by the association at a regular meeting at least one month prior to the election of the officers.

Only those persons who have consented to serve if elected shall be nominated for, or elected to such office.

The Vice-President shall fill a vacancy occurring in the office of President. A vacancy in the office of Secretary or Treasurer shall be filled by a member appointed by the President with the approval of the Board of Directors.

There shall not be more than one officer from any one household.
