Re: Articles of incorporation for Not For Profit Corporation.

**ARTICLES OF INCORPORATION  
OF  
THE WEHRLE FOUNDATION, Inc.**

The undersigned, all of who are citizens of the United States, desiring to form a corporation, not for profit, under the General Corporation Act of the state of Florida, do hereby certify:

**Article I - Name:**

The name of said corporation shall be **The Wehrle Foundation, Inc.**

**Article II - Principal Office:**

The place in this state where the principal office of the Corporation is to be located is 3360 O'Berry Rd. that is located in the city of Kissimmee, Florida, Osceola County 34746-3903.

**Article III - Purpose:**

The purpose or purposes for which said Corporation is formed are: to help bring about the physical, social, civic, and educational betterment of mankind along humanitarian lines; to take such steps as shall be calculated to produce a citizenry that will be more sound and effective because of more satisfactory conditions of environment and education; to improve the physical, mental and moral conditions of humanity and, generally, to advance charitable, benevolent and educational objectives; to extend financial or other aid or assistance NOT TO ANY INDIVIDUAL OR INDIVIDUALS, but to such organizations, whether incorporated or not, as are operated for charitable, scientific, literary or educational purposes, or for the prevention of cruelty to children or animals, no part of the net earnings of which inures to the benefit of any member, private shareholder, individual, trustee or director, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation; and generally, to such organizations as are operated in furthering the purposes hereinbefore named or any of them without gain or profit to their members, private shareholders, trustees or directors and are to establish, promote, maintain and endow, in whole or in part, any such organization or institution; and, incidentally, to the main purposes aforesaid, this Corporation shall have the power to require by deed, bequest, devise, gift, purchase, or otherwise personal and real property, to hold, invest, re-invest, manage, and dispose of the same and to do all other things necessary of incidental to the main purposes aforesaid or any of them as fully and completely as a natural person might or could do and in any capacity; any and all gifts, in any form, to this Corporation to be irrevocable; and this Corporation to be operated exclusively for charitable, scientific, literary, or educational purposes, or for the prevention of cruelty to children or animals and of the net earnings of this Corporation to inure to the benefit of any member or trustee of this Corporation.

**Article IV - Manner of Election:**

Members in said Corporation are subject to the following qualifications: Only such persons shall be members of this corporation as are chosen to be such by the unanimous vote of the said original member(s) of this corporation, namely Philip C. Wright, or by unanimous vote of such persons as shall be serving this Corporation as Trustees at the time such choice is made, or as provided in the code of Regulations.

**Article V - Initial Directors/Officers (optional):**

The following person(s) shall serve said Corporation until the first annual meeting or other meeting called to elect trustees: The following named person(s), the subscriber(s) to these Articles, are to be the members of this Corporation upon organization:
