## ARTICLES OF INCORPORATION

OF 2001 NOV -7 AM 10: 21 TRINITY UNITED METHODIST CHURCH OF LAKE CITY, FLORIDA, INC.

SECRETARY OF STATE

The undersigned, all of whom are citizens of the United States, desiring Ald ACHASSEE FLORIDA corporation, not for profit, under the provisions of Chapter 617 of the Florida Statutes, do hereby certify:

The name of said corporation shall be Trinity United Methodist FIRST: Church of Lake City, Florida, Inc.

The place where the principal office of the corporation is to be located is 310 Martin Luther King, Jr., Drive, Lake City, Columbia County, Florida and its mailing address is P.O. Box 3508, Lake City, FL 32056

The purpose or purposes for which the corporation is formed are as THIRD: more fully set forth in the Discipline of the United Methodist Church or as may hereafter, from time to time, be amended including:

- The promotion of the Christian religion through the (a) preaching of the Word of God, the administration of the sacraments, ordinances, and other means of grace, the maintenance of worship, the edification of believers, the evangelization of the world, and the promotion of the missionary and benevolence causes.
- Receiving, holding, and disbursing gifts, bequests, and (b) funds arising from all sources.
- Acquiring, owning, and maintaining real estate, buildings (c) and other property real or personal, incidental, necessary, or proper to carry out said objects.
- Doing of any and all things necessary or incident to the (d) accomplishment of such purposes.
- All of the above shall be in accordance with the Doctrines, Laws, Usages, Discipline, and Ministerial appointments of The United Methodist Church.

The following persons shall serve as the initial trustees of said FOURTH: corporation and shall serve as provided in the Discipline of the United Methodist Church:

The method of electing these trustees or directors shall be as set forth in the bylaws out of the Discipline.

FIFTH: Upon the filing of these Articles of Incorporation of Trinity United Methodist Church of Lake City, Florida, Inc., the society or association now known as Trinity United Methodist Church, an unincorporated group not for profit, and the members of such society or association shall be members of such corporation, and all the rights, privileges, immunities, powers, franchises, authority, property, and obligations of such unincorporated society of association shall thereupon pass to, vest in, and be the rights, privileges, immunities, powers, franchises, authority, property, and obligations of Trinity United Methodist Church of Lake City, Florida, Inc., a corporation not for profit.

SIXTH: The corporation shall support the Doctrine of The United Methodist Church and all its property, both real and personal, shall be subject to the *Discipline*, Laws, Usages, and Ministerial appointments of The United Methodist Church as are now or shall be, from time to time, established, made, and declared by the lawful authority of the said church.

**SEVENTH:** The corporation, in conformity with the *Discipline* of The United Methodist Church, shall have the power to receive, acquire, and hold title, in trust or otherwise, to real and personal property, and to improve, encumber, lease, sell, convey, and dispose such property.

**EIGHTH:** Subject to the provisions of the *Discipline*, the corporation shall have the power to erect and maintain buildings for the worship of God, for training in Christian faith and conduct, and for Christian social intercourse, and to purchase, lease, and/or rent

and otherwise acquire or build and maintain residences for the use and occupancy of its ministers.

**NINTH:** The business of this corporation shall be conducted in conformity with the *Discipline* of The United Methodist Church as the same now exists or as may hereafter be amended, changed, or modified, and the bylaws of the corporation shall include the *Discipline* of The United Methodist Church and no bylaws shall be adopted inconsistent with the provisions of said *Discipline*.

In addition to the powers and duties granted to this corporation by the *Discipline* of The United Methodist Church, the corporation assumes for itself all the rights, powers and privileges and immunities which are now, and which may be during the existence thereof be conferred by law upon corporation with a similar character, provided the same are not inconsistent with said *Discipline*. All amendments, bylaws, and regulations of this corporation shall at all times be in conformity with the *Discipline* of The United Methodist Church.

But notwithstanding the above, however, at no time shall any of the amendments, bylaws, or regulations of the corporation be prohibited by or in conflict with the nonprofit corporate laws of the State of Florida.

**TENTH:** The members of the corporation shall mean the membership of the corporation and shall be composed of such persons (ministerial and lay) as from time to time shall be defined in accordance with the *Discipline* of The United Methodist Church, and such members thereof shall have only such voting and other rights as now exist or may hereafter be granted by the *Discipline* of The United Methodist Church.

ELEVENTH: If for any reason the corporation shall be abandoned, discontinued, or cease to exist as a legal entity and its charter shall expire or be terminated, the title to all its property both real and personal shall be vested and be the property of the Florida annual conference of The United Methodist Church, pursuant to said *Discipline* of The United Methodist Church, or to an organization qualified under § 501(c) (3) of the Internal Revenue code of the United States.

TWELFTH: CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE: PURSUANT TO THE PROVISIONS OF SECTION 617.0501, FLORIDA STATUTES, THE UNDERSIGNED CORPORATION, ORGANIZED UNDER THE LAWS OF THE STATE OF FLORIDA, SUBMITS THE FOLLOWING STATEMENT IN DESIGNATING THE REGISTERED OFFICE/REGISTERED AGENT, IN THE STATE OF FLORIDA.
