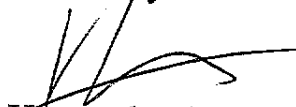

**ARTICLES OF INCORPORATION
OF
EMMANUEL SERVICES, INC
(a corporation not for profit)**

We, the undersigned, with other persons being desirous of forming a corporation for charitable and philanthropic purposes, under the provision of the Florida Statutes, do agree to the following:

ARTICLE I

- (a) The name of this corporation is Emmanuel Services, Inc.
- (b) The existence of the corporation will be perpetual
- (c) The principal office of this corporation will be located at 4360 W Oakland Park Boulevard, Lauderdale Lakes, Fl 33313.
- (d) The resident agent of the corporation is Kirby Thurston whose address is 700 NW 18th Street, Pompano Beach, Fl 33060.

ARTICLE II

- (a) The general nature of the objects and purposes of this corporation shall be to provide, on a not for profit basis, housing & counseling to youths and their families.
- (b) This corporation is irrevocable dedicated to, and operated exclusively for, nonprofit purposes: and no part of the income or assets of the corporation shall be distributed to, nor inure to the benefit of, any individual.

ARTICLE III

This corporation is empowered:

- (a) To buy, own, sell, convey, assign, mortgage or lease any interest in real estate and personal property and to construct, maintain and operate improvements that are necessary or incident to the provision of such housing as described in Article II hereof.
- (b) To borrow money and issue evidence of indebtedness in furtherance of any or all of the objects of its business and to secure the same by mortgage, pledge of other lien on the corporation's property.

- (c) To do and perform all acts reasonably necessary to accomplish the purposes of the corporation
- (d) In the event of the dissolution of the corporation or the winding up of its affairs, the corporation's property shall not be conveyed or distributed to any individual or organization created or operated for profit, but shall be conveyed or distributed only to an organization created and operated for nonprofit purposes similar to those of this corporation.

ARTICLE IV

The number of directors of the corporation is not less than 5 nor more than 12, elected by the members of the corporation from the membership. The directors of the corporation must, at all times, be members of the corporation. No nonmember of the corporation may sit as a director. The original directors and the term for which each shall serve are set below:

The officers of the corporation, as provided by the By-Laws of the corporation, shall be elected by the directors of the corporation, in the manner therein set out, and shall serve until their successors are selected and have qualified. The directors shall elect the regular officers of the corporation at the annual meeting, for terms of one year. The secretary and treasurer may be one and the same person, and need not be a director of the corporation. Other officers must be directors of the corporation. The annual meeting shall be held on the 1st Monday in May of each year.

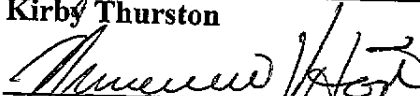
ARTICLE V

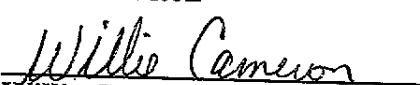

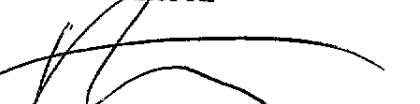
ARTICLE VI

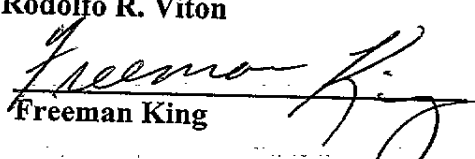

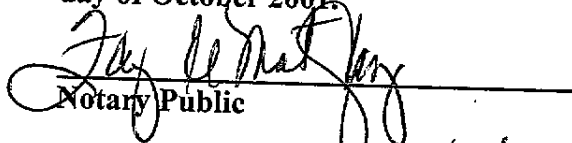
