**ARTICLES OF INCORPORATION
OF
THE SOUTHERN OUTRIDERS OF REDLAND FLORIDA, INC.**

In compliance with Chapter 617, Florida Statutes (F.S.), and other applicable laws of the State of Florida relating thereto, the following Articles of Incorporation are together for the purpose of becoming a not-for-profit corporation:

ARTICLE I - NAME

The name of this corporation is THE SOUTHERN OUTRIDERS OF REDLAND FLORIDA, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 15305 S.W. 260 Street, Homestead, Florida 33032-6209.

ARTICLE III - PURPOSE

The general nature of business to be transacted by this corporation is a not-for-profit, all volunteer, equestrian organization designed for families to engage in the encouragement, development, promotion and participation in equestrian activities, the improvement of horses and riders, and community service.


This corporation may also engage in participating, holding or sponsoring all types of equestrian activities, including, but not limited to, shows, events, clinics, parades, rodeos, trail rides, campouts, and walk-a-thons.

ARTICLE IV - MANNER OF ELECTION

This corporation shall have three (3) directors, initially, who shall hold office for the first year of the existence of the corporation and until their successors are appointed or elected. The number for directors may be increased or diminished from time to time, by the constitution and by-laws, but shall never be less than three (3).

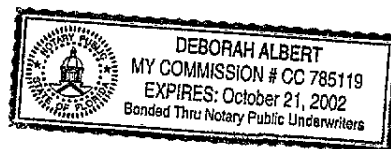
