Article II Principal Office

Article III Purpose

The purpose for which the corporation is organized is:

A To advance the general welfare of the community in all fields of human endeavor and to promote better understanding between all people.

B To promote and to adhere to genuine democratic principles upholding such basic rights such as freedom of expression, freedom of choice, freedom of faith, and inalienable human rights as stated in the constitution and the laws of the United States of America.

C To carry a continuing public information program which will keep the members and the public at large informed of the work and progress of Haitian-American Community Help Organization, Inc.

D To dedicate Haitian-American Community Help Organization, Inc. as a whole to

Develop and improve services to all members of the community by any or all of the following means:

- 1 By mustering the expertise, knowledge, and professional skills of members of the community to solve human problems
- 2 By offering to elected and appointed officials of the government, suggestions of and recommendations based on the results of surveys, studies, and investigations.
- 3 By providing a forum for all persons engaged in public and community affairs, for an interchange of ideas and opinions, to discuss mutual problems, and to form a basis opinions, to discuss mutual problems,

and to form a basis for uniting diversity, through related interests towards the achievement of common goals.

Article IV MANNER OF ELECTION
