**ARTICLES OF INCORPORATION**

**OF**

The undersigned acting as Incorporator of a corporation not-for-profit under Chapter 617 of the Florida Statutes adopts the following Articles of Incorporation for such corporation.

**ARTICLE I  
NAME**

The name of the corporation shall be OPEN UP MY HEART, INC.

**ARTICLE II  
PERIOD**

The period of its duration is perpetual.

**ARTICLE III  
PURPOSE**

The purpose for which the corporation is organized shall be to engage in any activities permitted by law, including, but not limited to providing monetary aid to victims of terrorists activities by soliciting funds from the general public in accordance with the rules established in the State of Florida and the United States of America.

**ARTICLE IV

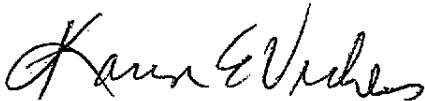

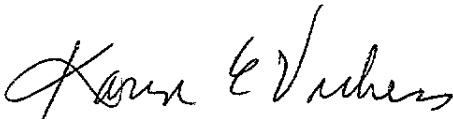
