The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be: **COMMONWELTH, SPECIAL AUDULT INC.**, (hereinafter referred to as the "Nonprofit").

ARTICLE II. PURPOSE

The purpose and object of the Nonprofit shall be to teach and spread the principals of good citizenship and community responsibility. The Nonprofit shall also conduct any and all business consistent with the laws of the State of Florida and United States of America.

ARTICLE III. PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be 3424 Deer Street, Jacksonville, Florida 32254.

ARTICLE IV. TERM OF EXISTANCE

Commencing on the date filed, and shall have perpetual existence.

ARTICLE V. MEMBERSHIP

Pursuant to the By-Laws, membership in, and services offered by the Nonprofit are open to all individuals, on a non discriminating basis, who accept principals of good citizenship and community responsibility.

ARTICLE VI. BOARD OF DIRECTORS

The business affairs of the Nonprofit shall be managed by the Board of Directors. The Board of Directors shall be elected by the members of the Nonprofit from among the membership at the annual membership meeting as provided in the By-Laws. The number of members of the first Board of Directors shall be five. The names and addresses of the persons who are to serve as the initial Board of Directors of the Ministry until their successors are chosen are:

ARTICLE VII. BY-LAWS

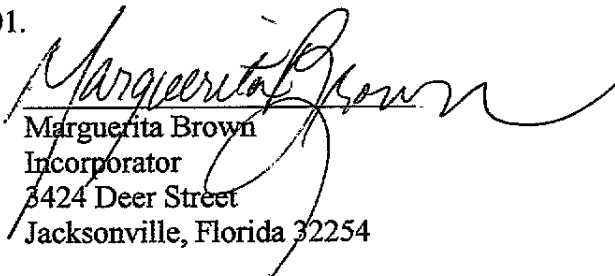
The Board of Directors shall adopt by a majority vote the original By-Laws of the Nonprofit.

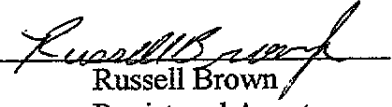
**CERTIFICATE OF DESIGNATION OF
