ARTICLE III. Purpose of Corporation

The corporation is organized for the purpose of raising funds for and distribution of those funds to pay for scholarships for low income children to attend athletic programs at local organizations and recruiting low income children to attend such programs, provided the organizations are described in Section 501(c)(3) of the Internal Revenue Code and are exempt from taxation under Section 501(a) of the Internal Revenue Code.

ARTICLE IV. Distribution of Assets

In the event of dissolution of the Corporation, all assets shall be distributed to one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations as the Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE V. Board of Directors

The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than three directors. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of the Corporation. The directors shall be appointed by the President of the Corporation and shall protected from personal liability to the fullest extent permitted by applicable law.


