In Compliance with Chapter 6117, F.S., (Not for Profit)

ARTICLE I NAME

NAME OF THE CORPORATION SHALL BE: FUTURE OF LIFE, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

IMMEDIATE PURPOSE

THE PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED IS THAT WE ARE DEDICATED TO PROVIDING NATIONAL SUPPORT FOR CLINICAL RESEARCH IN VARIOUS CANCER RESEARCH, WHILE IMPROVING THE MEDICAL ENVIRONMENT FOR ALL BY GATHERING MONEY AND DONATING IT TO NON-PROFIT ORGANIZATIONS THAT ARE SET UP FOR RESEARCH AND TREATMENT OF THE DISEASES WITHOUT THE MAJORITY OF MONEY GOING ON ADMINISTRATION COSTS. IN CONJUNCTION WITH ESTABLISHED RESEARCH AND TREATMENT ORGANIZATIONS, THE MONEY RAISED CAN GO DIRECTLY TO RESEARCH SINCE THESE ORGANIZATIONS HAVE ALREADY BEEN SET UP EITHER PRIVATELY OR FEDERALLY AND THEIR ADMINISTRATION COST HAVE ALREADY BEEN SET. MONEYS WILL BE COLLECTED BY DIRECT DONATION OF THE PUBLIC AND PRIVATE SECTORS, AND BY OTHER MEANS THAT THE DIRECTORS APPROVE WHICH WILL BE IN COMPLIANCE WITH THE LAWS OF THE STATE OF FLORIDA. WEB SITE DONATIONS WILL ALSO BE ACCEPTED, WHICH WILL BE CONTROLLED AND MONITORED BY THE DIRECTORS.

FUTURE PURPOSE IN ADDITION TO THE ABOVE

AS THE CORPORATION GROWS WE WOULD LIKE TO SET UP MEDICAL FACILITIES, WHETHER IN JOINT VENTURE OR SUPPORTIVE ROLES, TO THE HOMELESS AND NEEDY FOR PREVENTION AND TREATMENT OF ILLNESS AND DISEASE TO HELP TAKE THE BURDEN OFF OF PRIVATE HOSPITALS AND MEDICAID IN THE STATE OF FLORIDA
