Articles of Incorporation

For

FAITH IN THE WORD OUTREACH MINISTRIES INC

The Articles of Incorporation are signed and acknowledged by the incorporator for the purpose of forming a non-profit corporation act as follows:

Article I

Name: The name of the proposed corporation is the FAITH IN THE WORD OUTREACH MINISTRIES INC.

Principal address: 437 NE 14 Avenue, Boynton Beach, FL 33435

Principal Location: The principal location of the Corporation will be in the city of Boynton Beach in the County of Palm Beach and State of Florida, but branches may be established at any place within or without the State of Florida.

Article II

Duration: The existence of this corporation shall be perpetual.

Article III

Purpose: The corporation is organized as non-profit corporation for the following purpose.

(A) The primary and specific purposes are:

1. To teach and proclaim the written word of God, and uphold it as the foundation of all spiritual truth.
2. To put forth religious outreach crusades and tent revivals, and various outreach programs, that will aide in the proclaiming of the written word of God.
3. To establish churches, to ordain ministers of the gospel authorized by it to teach and minister unto its members, celebrating marriages and burial of the dead, and to exercise such authority over its membership though suitable regulations and by-laws as may be appropriate for the establishment.

Article IV

Manner of Election of Directors:

1. The initial Board of Directors shall be elected by the incorporators of this corporation.
2. New members hereinafter shall be elected by 2/3 vote of the Board of Directors.
