The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I: The name of the corporation is NUT ISLAND HOMEOWNERS ASSOCIATION, INC.

ARTICLE II: The corporation shall exist for perpetuity commencing on the date of 11-14-01 execution of these Articles.
