**ARTICLES OF INCORPORATION
OF

INC.**

ARTICLE I

The name and address of this principal corporation is **Reuben & Emily Miller (REM) Community Development, Inc.**, 4015 North US #1 North, Cocoa, FL 32927, Brevard County. The corporation is organized pursuant to **FLORIDA** Nonprofit Corporation Code.

ARTICLE II

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. 
ARTICLE THREE

- (A) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code.
- (B) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax

under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

ARTICLE SEVEN


The property of this corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

ARTICLE EIGHT

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
