**ARTICLES OF INCORPORATION
OF
QUAN L. MILLER MINISTRIES , INC.**

ARTICLE I

The name and address of this principal corporation is **Quan L. Miller Ministries , Inc.**, 4015 North US #1 North, Cocoa, FL 32927, Brevard County. The corporation is organized pursuant to **FLORIDA** Nonprofit Corporation Code.

ARTICLE II


This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for Religious purposes. To establish structured support services for Evangelistic, Economic Development and Other Ministries to support outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the Corporation creed/bylaws as a pastor to spread the gospel of Jesus Christ. ARTICLE THREE

The duration of this corporation shall be perpetual, no stock and shall have no members.

ARTICLE FOUR
